महा वद्यालय

कॉलेज का नाम श्री अरबिंदो घोष के नाम पर रखा गया है। श्री अरबिंदो घोष का जन्म 15 अगस्त 1872 को कोलकाता में हुआ था। उनका निधन 5 दिसंबर 1950 को हुआ था। वह एक भारतीय दार्शनिक, योगी, महर्ष, कव और भारतीय राष्ट्रवादी थे। उन्होंने मानव प्रगति और आध्यात्मिक वकास पर अपने दृष्टिकोण प्रस्तुत कये। उन्होंने अपने लेखन में प्राच्य और पाश्चात्य दर्शन, धर्म, साहित्य और मनो वज्ञान का संश्लेषण कया। उनकी मुख्य साहित्यिक कृतियाँ- 'द लाइफ डवाइन' और 'संथे सस ऑफ योगा' हैं। उन्होंने एक महाकाव्य 'सा वत्री: ए लेजेंड एंड ए संबल' की भी रचना की। भारत ने श्री अरबिंदो घोष के जन्म दिवस के शुभ दिन, यानी 15 अगस्त, वर्ष 1947 को ब्रिटिश शासन से अपनी स्वतंत्रता हा सल की।

1984 में स्था पत, श्री अरिवंदो कॉलेज (सांध्य) दिल्ली वश्व वद्यालय का एक संघटक महा वद्यालय है। वद्यालय ने अपने वकास और सफलता के सभी चरणों को पूरा करते हुए 40 वर्ष पूरे कर लए हैं। इस अव ध के प्रत्येक वर्ष को इस युवा संस्थान इतिहास में एक मील के पत्थर के रूप में देखा जा सकता है। 1988 में कॉलेज ने छात्राओं के लए अपने द्वार खोल दिये। कॉलेज की शुरुआत केवल बी.ए. में शक्षा प्रदान करने से हुई। इन वर्षों में, बी.कॉम (पास व ऑनर्स), बी.ए. (ऑनर्स) हिंदी और बी.ए. (ऑनर्स) अनुप्रयुक्त मनो वज्ञान में पाठ्यक्रम की शुरुआत की गई। बी ॰ ए (ऑनर्स) अंग्रेजी और बी.ए. (ऑनर्स) अर्थशास्त्र शैक्ष णक वर्ष 2017-18 में शुरू कया गया था। मानव संसाधन वकास मंत्रालय के नेशनल इंस्टीट्यूट रैं कंग फ्रेमवर्क (एनआईआरएफ) द्वारा प्रदर्शन के आधार पर कॉलेज को शीर्ष 150 उच्च शक्षा संस्थानों में रखा गया है। वर्ष 2022-2023 से स्नातक पाठ्यचर्या रूपरेखा (यूजीसीएफ) की शुरुआत की गई है। शैक्ष णक उत्कृष्टता के अलावा, कॉलेज छात्रों के एकीकृत और व्यक्तित्व के सर्वांगीण वकास पर वशेष जोर देता है। अनुशासन और ईमानदारी इस संस्था की पहचान हैं। हमारे छात्र जिम्मेदारी, दृढ़ वश्वास, उत्साह और साहस के साथ जीवन में महत्वपूर्ण स्थान रखते हैं और हमारे सामने मौजूद लक्ष्यों में हमारे वश्वास को साबित करते हैं।









ABOUT THE COLLEGE

The College is named after Sri Aurobindo Ghose. Sri Aurobindo Ghose was born on 15 August, 1872 in Kolkata. He passed away on 5 December, 1950. He was an Indian philosopher, yogi, maharishi, poet, and Indian nationalist. He introduced his visions on human progress and spiritual evolution. He synthesised the oriental andoccidental philosophies, religions, literature and psychology in his writings. His main literary works are *The Life Divine*, and *Synthesis of Yoga*. He also composed Savitri: A Legend and a Symbol, an epic poem. India won its independence from the Britishrule on the auspicious day of Sri Aurobindo Ghose's birth day, that is on August 15,in the year 1947.

Established in 1984, Sri Aurobindo College (Evening) is a constituent College of University of Delhi. The College has completed 40 years that charter all the phases of its growth and success. Each year of this period can be seen as a milestone in the history of this young institution. In 1988 the College opened its doors to women students. The College began by offering instructions only in B.A. (Pass) and B.Com. (Pass). Over the years, courses in B.Com. (Hons.), B.A. (Hons.) Hindi and B.A. (Hons.) Applied Psychology were introduced. B.A. (Hons.) English and B.A. (Hons.) Economics were introduced in the academic year 2017-18. The college has been placed amongst the top 150 Higher Education Institutions on Performance by the National Institute Ranking Framework (NIRF) of the Ministry for Human Resource Development. From the year 2022-2023 the Undergraduate Curriculum Framework (UGCF) has been introduced. Apart from academic excellence, the college lays special emphasis on the development of an integrated and well-rounded personality of the students. Discipline and sincerity are the hallmarks of this institution. 1. Commencement of Phase II of CSAS

After the declaration of results of the Common University Entrance Test (CUET)-UG by the National Testing Agency, the University announces the commencement of Phase-II of Common Seat Allocation System (UG)- 2024 (CSAS (UG)) from **Thursday, August,01 2024.**

In this phase, the candidates who had successfully completed the Phase-I must login to their dashboard (https:// ugadmission.uod.ac.in) to choose their preferred Programs and College combinations, subject to fulfillment of the eligibility criteria.

Candidates who have still not registered themselves on the CSAS portal will also be able to register as the University has decided to keep both the phases open till **04:59 p.m. Wednesday, Augut 07 2024.** Phase-I and Phase-II will close at **04:59 p.m, Wednesday, Augut 07 2024,** and the preferences saved/submitted by the candidates will get auto-locked on reaching the deadline of **05:00 pm Friday, August 09,2024.**

2. Calculation of Program-Specific merit score

In Phase -II the Candidates will have to map the subjects studied by them in Class XII to those in which they have appeared in CUET-2024 only those CUET Papers will be considered in which the candidates have passed his/her Class XII board exam. 
Registrations and Admission to Undergraduate Programs

REGULAR STUDENTS

The candidate must be a citizen of India.

For admission to Undergraduate Programs at University of Delhi, all candidates (including those applying under supernumerary quota) must register for CUET (UG)-2024 at http://cuetug.ntaonline.in

For seat allocations and admissions, candidates must apply to the Common Seat Allocation System (CSAS(UG)-2024) of University of Delhi. Details related to allocations and admissions through CSAS(UG)-2024 etc. will be notified separately. Candidate must visit www.admission.uod.ac.in on regular basis.



Important Points

- Admissions to all Undergraduate Programs at the University of Delhi will be based on the scores obtained in CUET (UG) - 2024, except for admissions to the School of Open Learning (SOL), Non-Collegiate Women Education Board (NCWEB) and for Foreign Nationals.
- An eligible candidate desirous of seeking admission to the Undergraduate Program(s) of the
 University of Delhi for the academic session 2024-25 must read the contents of this Bulletin
 of Information (BOI) 2024-25, as well as the notifications, updates and information published
 on the admission website of the University of Delhi very carefully.
- The candidate must have studied and passed Class XII examination or its equivalent from a single recognized board.
- The candidate must have studied and passed Class XII examination of any Board / university in India, or any foreign country recognized as equivalent to the 10+2 system by the Association of Indian Universities (AIU).
- For admission to University of Delhi, it is mandatory for the candidate to appear in CUET (UG) - 2024 in those subjects in which s(he) is appearing/has passed Class XII.
- 6. In case the subject studied at Class XII is not mentioned in the CUET (UG) 2024, the candidate must appear in the Language/Domain Specific subject that is similar/closely related to the subject s(he) has studied at Class XII (for example, if a candidate has studied Biochemistry in Class XII, s(he) must appear in Biology in CUET (UG) 2024). For establishing similarity of CUET (UG) subjects with subjects taken in Class XII, at least 50% of the syllabus of should match. The University reserves the right for establishing the similarity. The decision of University in this regard shall be final and binding.
- Allocation and admission will be based only on the combination of Language, Domain Specific subjects and/or General Test in which a candidate has appeared in CUET (UG) – 2024 as per the respective Program-Specific Eligibility.
- Only the scores obtained in CUET (UG) 2024 will be considered for admissions to the academic year 2024-25.
- The candidate must read the Program-Specific requirements carefully and then appear in Language and/ or Domain Specific Subjects of the CUET (UG) - 2024.
- 10. The candidate is advised to check that s(he) satisfies all eligibility criteria for the Program(s) for which s(he) is appearing in CUET (UG) 2024. Admission is subject to the candidate fulfilling the eligibility requirements prescribed for applying to the concerned program of study. In case a candidate does not meet any eligibility criteria prescribed for applying to the concerned program and appears in the entrance test, it is at the candidate's own risk and cost. If at any stage, it is found that eligibility requirements are not fulfilled, the admission, if granted, shall be cancelled ipso facto.

- Grievance related to non-appearance in CUET (UG) 2024 or the required Language, Domain Specific subjects and/or General Test will not be entertained.
- 12. Before registering for CUET (UG) 2024, the candidate is advised to carefully read the Bulletin of Information (BOI) 2024-25 and consult the University of Delhi Act, 1922 and the Statutes. The Ordinances, Rules and Regulations of the University of Delhi, available on the University website, would be binding on them.
- 13. Candidates must be careful while filling the CUET (UG)-2024 form as certain fields such as Name, signature and photograph of the candidate will be later auto-integrated by University of Delhi from CUET (UG)-2024. These fields will be non-editable.
- 14. The name of the candidate claiming reservation must match with the Candidate's name as it appears on their corresponding School Board qualifying certificates and in CUET (UG)-2024. Similarly, the parents' names must also match in the certificates.
- 15. As per Ordinance-I of University of Delhi, there is no minimum age bar for admission to the undergraduate programs in the University and its colleges except in the programs where the respective regulatory bodies, such as Medical Council of India (MCI), All India Council for Technical Education (AICTE), Bar Council of India (BCI), National Council for Teacher Education (NCTE), Dental Council of India (DCI), etc. have prescribed the minimum age requirement in their regulations.
- Gap year will not be a bar for purpose of admission to undergraduate programs. However, such candidates must also appear in CUET (UG) - 2024 for admissions in academic year 2024-25.
- Appropriate proration in CUET (UG) 2024 scores will be done wherever required (including supernumerary quota).

ELIGIBILITY REQUIREMENTS FOR UNDERGRADUATE ADMISSIONS

COMMON MINIMUM ELIGIBILITY

The candidate must have passed the Class XII or its equivalent examination from a single recognized board.

For the purpose of ascertaining the Minimum Eligibility, the marksheet/ degree of only one board will be considered. (For example, If a candidate has appeared in CBSE Board Examination with five subjects except for Mathematics and later appears and passes Mathematics from another board such as the National Institute of Open Schooling (NIOS), the minimum eligibility shall be ascertained from his/her mark sheet issued by CBSE only).

PROGRAM-SPECIFIC ELIGIBILITIES

Candidate must refer to the Program-Specific Eligibility to choose the subjects in which s(he) should appear in CUET(UG) - 2024.

It is mandatory for the candidates to appear in CUET(UG)-2024 in those subjects in which s(he) is appearing/ has passed Class XII. For the purpose of ascertaining Program Specific Eligibility and for mapping the CUET subject(s) with Class XII subject(s), marksheet of more than one recognized board may be considered provided the candidate has passed those subject in class XII.

B.A. (HONS.) HINDI

B.A. (HONS.) APPLIED PSYCHOLOGY

BA. 

Candidates shall be required to upload copies of relevant certificates/documents at the time of applying (as applicable) and produce the same certificates/documents in original at the time of physical verification at the College.


- 1. Class X Certificate in the name of the candidate, indicating date of birth and Parents' names.
- 2. Class XII Marksheet in the name of the candidate. The name of the candidate must match with the CUET(UG)-2024 form.
- 3. SC/ST/OBC-NCL/EWS/Minority/CW/KM/PwBD Certificate (in the name of the Candidate) issued by the competent issuing authority. The name of candidate claiming reservation under SC/ST/OBC-NCL/EWS/ Minority/ CW/ KM/ PwBD must match the name that appear on his/her corresponding School Board qualifying certificate and in CUET(UG)-2024. Similarly, his/her parents' names must match in both sets of certificates.
- 4. OBC Non-Creamy Layer Certificate (in the name of the Candidate) issued by the competent issuing authority, and wherein the caste is in the OBC Central List issued by http://ncbc.nic.in. The name of the candidate claiming reservation under OBC -Non-Creamy Layer must match with the name as it appears on his/her corresponding School Board qualifying certificate and in CUET(UG)-2024; similarly, the parents' names must match in both sets of certificates. Income certificate must be issued after March 31, 2024. The format of the OBC-NCL certificate is given in Annexure IV.
- 5. EWS Certificate (in the name of the candidate) from the competent issuing authority certifying the candidate can claim reservation under this category. The name of the candidate claiming reservation under this category must match with the name that appears on his/her corresponding School Board qualifying certificate; similarly, his/her parents' names must match in both sets of certificates. Income certificate must be issued after March 31, 2024. Refer to Annexure IV for the format of the certificate.
- 6. Candidates claiming admission through ECA/Sports supernumerary quota must upload self-attested copies of the requisite certificates and produce the relevant required certificates when sought
- 7. . . 7. For applying to B.Sc Physical Education, Health Education and Sports, candidates must upload the following (Details in Chapter 20): a) Medical Fitness certificate as per the format given in Annexure IV. b) Upto three Sports Proficiency Certificates.
- 8. Candidates who have not studied Music as a subject in Class XII and wish to apply for B.A. (Hons.) Music must upload a certificate as mentioned in Chapter 20 of CSAS(UG)-2024.
- 9. PwBD disability certificate should be in the name of the candidate issued by a recognized Government Hospital, bearing a photograph of the candidate (Refer to Annexure IV for the format of the certificate). Disability Certificates issued after 01.06.2021 must be as per the Gazette Notification no.1736 (E) dated 05.05.2021 issued by the Department of Empowerment of Persons with Disabilities and applied through UDID portal. However, Disability Certificates issued before 01.06.2021, will be considered as per other existing applicable rules and notifications of the Department of Empowerment of Persons with Disabilities and the University of Delhi.
- 10. Candidates applying under the CW category must upload the Educational Concession Certificate (ECC), (in the name of the candidate) in the format wherein the Priority is clearly mentioned. Refer to Annexure IV for the format of the certificate.
- 11. Candidate applying under the Kashmiri Migrant category must upload the relevant certific in the 59 correct format issued by Divisional Commissioner/ Relief Commissioner.
- 12. Candidates belonging to Sikh and Christian Minority categories must produce the certificate of minority at the time of admission containing details of the Minority Status of the candidate issued by any Government Organization/Local Municipality/ Panchayat/ Education Board/ School Leaving Certificate, etc., or as applicable, issued by DSGMC/DMC or Baptism Certificate and/or Church membership certificate. For more information related to issuance of minority certificate for Sikh candidates, refer to Chapter 18.

- 13. Candidate who wishes to seek admission under the orphan's quota will have to upload certificate from a Govt. recognized Orphanage/Charitable Home or Death certificate of both the parents
- 14. Candidates who wish to seek admission under UoD Ward supernumerary quota must upload a valid employment certificate of his/her parent/s issued by the due officials. Only the employment certificate uploaded in CSAS(UG)-2024 Application form will be considered. I-cards, Aadhar Card and/or any other document will not be accepted.
- 15. For claiming admission in the category of Single Girl Child, the Father / Mother / Guardian (in case parents are deceased) shall have to upload copy of an affidavit to this effect, duly attested by the area District Magistrate/Additional Magistrate / Deputy Commissioner / Collector / Additional Deputy Commissioner / Deputy Collector/ 1st Class Stipendiary Magistrate / City Magistrate (not below the rank of 1st Class Stipendiary Magistrate), Sub- Divisional Magistrate / Taluka Magistrate / Executive Magistrate / Extra Assistant Commissioner, at the time of online registration and should produce original affidavit at the time of physical verification of documents. Refer to Annexure IV for format of affidavit.

Candidates shall be responsible for the quality and authenticity of the certificate they upload. Candidates must take utmost care to ensure the uploaded documents/certificates are authentic and accurate. Candidates will be responsible to produce documents/certificates as sought. All certificates/documents will be returned to the candidate by the College/Department upon completion of any physical verification that may be required at a later stage.

If the original certificates are not in English/Hindi, the English/Hindi version/translation of such certificates, duly certified by the Principal/Director or other competent authority of the last Institute attended, will be required during the time of verification.



Undergraduate Curriculum Framework UGCF – 2022

The UGCF - 2022 underlines the historical perspective, philosophical basis, and contemporary realities of higher education as enshrined in the National Education Policy (NEP – 2020) and endeavors to synchronize these cornerstones while charting the road ahead for the state of higher education.

The University of Delhi, a premier seat of teaching, learning, and research in higher education, acclaimed nationally and internationally, has nurtured the quest for reaching the peak in every sphere of education, in its true sense, in its contribution to the nation-building. Moreover, being a Central University mandated to act as the torch bearer in expanding the horizons of human resource development through the expansion of higher education, it has always paid an adequate premium towards constructive and meaningful innovation as a regular feature in its undergraduate curriculum development over the years.

A reflection of such sustained and continued endeavour is amply exemplified in the successive revision of undergraduate curricular framework over the decades, keeping pace with the emerging trends in higher education in the new millennium globally and its critical importance in enriching the youth of our nation, well equipped with the prevailing priorities of skill development through innovative and practical oriented teaching-learning more than anything else.

To actualize the noble objective, as succinctly brought out in the NEP - 2020, the University of Delhi has endeavored to explore the possibility of further restructuring and refinement of its undergraduate curriculum framework in line with the objective and underlying philosophy of the NEP - 2020 to capture the imagination of the youth of our nation which depicts the contemporary realities of our demographic advantage globally.

The resultant outcome of this comprehensive exercise undertaken by the University of Delhi is the UGCF - 2022 which not only underlines the hearth and soul of the NEP - 2020 in letter and spirit but also goes on to create a teaching-learning framework at the undergraduate level to attract the young minds towards research, innovation, apprenticeship, social outreach, entrepreneurship and similar such areas of human knowledge and endeavour while imbibing the truly charged academic environment of the University of Delhi and its constituent Colleges.









STRUCTURE AND SYLLABUS OF UGCF - 2022

The College is named after legendary philosopher of India, Sri Aurobindo Ghose, and ethics and value system are integral part of our indoctrination process. Therefore, while we subscribe completely by the university curriculum designed for all the constituent colleges, we always ensure that we supplement classroom teaching with adequate and effective training in morality and ethical understanding. We endeavour to bring value-oriented yet modern pedagogy to our students in an all-inclusive and non-discriminatory manner.

- 1.Entry level eligibility: The general feeder category for entry into Level 5 is the Secondary School Leaving Certificate obtained after successfully completing Grade 12. A programme of study leading to entry into the first year of the Bachelor's degree is open to those students who have met the entrance requirements, including specified levels of attainment at the secondary level of education mentioned in the programme admission regulations. Admission to the Bachelor degree programme of study is based on the evaluation of documentary evidence (including the academic record) of the applicant's ability to undertake and complete a Bachelor's degree programme which is specified in the UGC Guidelines for Multiple Entry and Exit Scheme in Academic Programmes Offered in Higher Education.
- 2. Number of hours of a credit course shall be defined by its component of lecture, tutorial and practical.
- 3. Every student has to study "Environmental Science and Sustainable Development" courses I and II of two credits each in the first year (I/II semester) and the second year (III/IV semester), respectively. The AEC pool will also consist of credit courses in languages listed in the Eighth Schedule of the Constitution of India, as updated from time to time. The University of Delhi shall extend necessary support to those Colleges (where faculty is not available) which may require it in course of teaching learning in these languages.
- **4.** Design of degrees: Students shall be able to design their own degrees according to their mission and aspiration for a future befitting to their ability and attainment, rather than following the conventional pathway.
- **5.** A student who pursues three years undergraduate degree programme in a specific discipline as a Core course [for example, B.A. (Honours) English, B. Com (Honours), B.Sc. (Honours) Physics and such other Programmes] will earn at least 80 credits in that discipline (from 18 DSCs and at least 2 DSEs of that discipline) and shall be awarded Honours degree in that discipline, if he/she exits after completion of VI semester.
- **6.** A student who pursues three years undergraduate degree programme in more than one discipline as core courses of study (for example B.A. in Social Sciences/ Humanities, B.Sc. in Life Sciences, B.Sc. in Physical Sciences, B.Sc. in Mathematical Sciences, Bachelor in Commerce Studies and such other programmes) he/she shall be awarded Bachelor's degree in that field of multidisciplinary course of study, if he/she exits after completion of VI semester.
- 7. If a student wishes to pursue four years Honours Degree with research, he/she shall compulsorily opt for a Research Methodology course in either VI Semester or VII Semester as GE.
- **8.** Dissertation/Academic Project/Entrepreneurship in the 4th year shall commence from VII semester and conclude in VIII semester. Detailed outcomes of each track chosen out of these three options shall be notified and assessment at the end of VII and VIII semesters shall be done accordingly.
- 9. Dissertation may be written in the Major or Minor or Interdisciplinary (combination of Major and Minor) discipline.
- 10. If a student mentioned at (6) above continues or re-enters the fourth year for pursuing an Honours degree in that field of multidisciplinary study, he/she has to choose only one of the disciplines he/she had studied as

core courses of study in the previous six semesters and earn credits from the 2DSCs and 6DSEs of that chosen discipline in the VII and VIII semesters and write dissertation or opt for Academic Project or Entrepreneurship.

- 11. If a student mentioned at (5) above, continues or re-enters to study the VII and VIII semesters in the same discipline, and writes dissertation mentioned at (9) above, but no Minor discipline is made out (i.e., credits earned in the GEs of any one discipline is less than 28 credits), then he/she shall be awarded 'Honours with Research' with Major in that discipline on successful completion of VIII Semester.
- 12. A student mentioned at (6) above, shall be awarded 'Honours' degree in that field of multidisciplinary study on successful completion of VIII semester. For example, B.A. (Honours) Social Sciences/ Humanities, B.Sc. (Honours) Life Sciences, B.Sc.(Honours) Physical Sciences, B.Sc. (Honours) Mathematical Sciences and Bachelor in Commerce Studies (Honours). Major and Minor shall be indicated on fulfilment of the conditions mentioned above at III(2)(b) and III(3)(b), respectively. For instance, a student who pursues four years B.A. (Honours) in Social Sciences/ Humanities with History, Political Science and Hindi as core courses, shall get Major in History, on successful completion of VIII semester, if he/she earns minimum 80 credits in History from 8 DSCs and at least 9 DSEs of History and writes dissertation on a topic related to History. Such a student shall get a Minor in Political Science/Hindi, if he/she earns minimum 28 credits from 6 DSCs and one DSE of Political Science/Hindi.
- 13. Only a student mentioned at (5) above who opts to write a dissertation in the Major/Minor subject in VII and VIII semesters in the fourth year, shall be awarded 'Bachelor of Field of Study/Discipline (Honours with Research) in Discipline'. For instance, a student who pursues B.Sc. (Honours) in Physics and writes a dissertation on a topic relating to Physics or the Minor in VII and VIII semesters, shall be awarded 'Bachelor of Science (Honours with Research) Physics. Major and Minor shall be indicated on fulfilment of the conditions mentioned above at III(2) (a) and III(3)(a), respectively.
- 14. A student who opts for 'Academic Project' or 'Entrepreneurship' in VII and VIII semesters, instead of writing dissertations, and has earned 28 credits in the relevant GEs, SECs, AECs & IAPC, shall be awarded Minor in Academic Project or Entrepreneurship, as the case may be. 'Bachelor of Field of Study/Discipline (Honours with Academic Project/ Entrepreneurship) in Discipline (Major) & Academic Project/ Entrepreneurship (Minor)'. If he/she is unable to earn the requisite 28 credits, he/she shall be awarded 'Bachelor of Field of Study/Discipline (Honours with Academic Project/ Entrepreneurship) in Discipline (Major).
- **15.** A student who a pursues four-year undergraduate degree programme shall be awarded after completion of the VIII semester an appropriate degree.
- 16. Exit Options: The minimum credit to be earned by a student per semester is 18 credits and the maximum is 26 credits. However, students are advised to earn 22 credits per semester. This provision is meant to provide students the comfort of the flexibility of semesterwise academic load and to learn at his/her own pace. However, the mandatory number of credits have to be secured for the purpose of award of Undergraduate Certificate/ Undergraduate Diploma/ Appropriate Bachelor's Degree in the field of Study/Discipline, to a student who chooses to exit at the end of even semesters (details provided in the table below).

Addition to Ordinance VIII

[EC Resolution No. 60-1/ (60-1-13) dated 03.02.2023]

Assessment pattern of Courses based on UnderGraduate Curriculum Framework – 2022 to be implemented from the Academic Year 2024-2025.

- 1. The assessment pattern that shall be adopted for the purpose of assessment of courses that have been approved by the Competent Authorities under the UGCF 2022 shall be as follows:
- (a) In any course where 01 credit is attributed to 'Tutorial', an objective assessment process has to be developed as a credit earned by a student in a course will eventually lead to its deposition in the Academic Bank of Credit of such student. Therefore, it is imperative that each credit earned by a student is adequately assessed and recorded accordingly.
- (b) In view of the above, the components of Tutorial have been listed so that at least some of these activities (listed at point no. 3 below) may be picked up by a student, in consultation with the teacher, as per rules devised for this purpose. The activities conducted shall be assessed through continuous assessment.
- (i) Some of the activities that may be done as component of tutorials are as follows:
 - Literature review
 - Book review
 - Movie review
 - Project activity (group)
 - Research cum presentation
 - Creative Writing/Paper writing
 - Group discussion
 - Problem Solving exercises
 - Any creative production (may be done in a group)
 - Innovative Project
 - Any other scholastic work related to application of conceptual understanding of the subject.

Further, out of forty marks allocated for Continuous Assessment of tutorial, five marks shall be for attendance, which shall be distributed as follows:

a. More than 67% attendance but less than 70% attendance
b. More than 70% attendance but less than 75% attendance
c. More than 75% attendance but less than 80% attendance
d. More than 80% attendance but less than 85% attendance
e. More than 85% attendance
-4 marks
-5 marks

There shall not be marks for attendance in Continuous Assessments for practical.

2.(i) Internal Assessment (IA) shall consist of marks secured in class tests, assignments/presentations and attendance. For instance or an Internal Assessment of 25 marks, Class tests shall comprise of 10 marks, Assignments/Presentations shall comprise of 10 marks and attendance shall one of 5 marks. Similarly, for IA of 30 marks, 6 marks shall be for attendance, 12 marks for class test and 12 marks for Assignments/Presentations

(ii)Six marks for attendance shall be distributed as follows:

a. More than 67% attendance but less than 70% attendance

b. More than 70% attendance but less than 75% attendance

c. More than 75% attendance but less than 80 % attendance

d. More than 80% attendance but less than 85% attendance

e. More than 85 % attendance

- 3.(i) To make Internal Assessment and Continuous Assessment fair and reasonable, it is necessary to strengthen the Monitoring Committee for Internal Assessment in every College, constituted as per clause 5 (ii) of Ordinance VIII-E of the Ordinances of the University. This Committee shall be responsible for the entire process of Internal Assessment in the College, including redressal of grievances, if any. The same Committee shall also look into the process of Continuous Assessment and redress grievances, if any.
- (ii)A student who is discontent with the decision taken by the Monitoring Committee for Internal Assessment of the College, with respect to the grievance submitted by him/her relating to Internal Assessment/Continuous Assessment, may file an appeal before an appellate body consisting of the Principal of the College, the Teacher-incharge of the department/senior faculty member, the concerned teacher who has assessed the aggrieved student and shall be chaired by the Nominee of Dean of Colleges or Director South Delhi Campus, under whose jurisdiction the concerned College falls.
- 4. The theory examination and internal assessment shall be a cumulative assessment of the teaching-learning done in the theory as well as tutorial classes.
- 5. Practical marks for courses of total four credits, shall comprise of(i)continuous evaluation (25%), (ii)end term practical examination (50%) and (iii)viva-voce (25%).
- 6. Practical marks for courses of total two credits shall comprise of(i)continuous evaluation (25%), (ii)end term practical /written exam (50%) and (iii)viva-voce (25%)
- 7. The variance of the total marks in various combinations of LTP structure shall be aligned with the help of "weighted average" calculated through an appropriately devised formula for conversion of marks to grades.
- 8. "The attendance requirement for continuous mode of assessment shall be as per Ordinance VII of the Ordinances of the University".
- 9. To enable students to improve their grades, the following may be adopted:



The Library is known as Knowledge centre and regarded as the heart of any educational institution. The College Library provides an environment for discovery, reflection and expansion of Information and knowledge. It is committed to excellence in an innovative information service and supporting learning process of the College.

The College has a fully furnished air-conditioned library. It is well-equipped, and its collection consists of more than 46500 volumes of books. The library has a rich Reference Section consisting of Reference books, Encyclopedias, Classic collection of Literature and Dictionaries etc. The library also subscribes to many magazines, newspapers, printed Journals and E-Journals and E-books (N-LIST E-Resources). The library is using Cloud based software, E-Granthalaya 4.0 software, which is developed by NIC.

KEY FACILITY OF THE LIBRARY:

- To provide facility of various relevant printed and e-resources to the Faculty members, Non-Teaching staff and the Students.
- To provide remote Access facility of N-LIST E-Resources to the Faculty members and students.
- To provide 08 computer systems in the library to access the Internet and various E-Resources.

महत्वपूर्ण नियमः

- 1. किसी भी परिस्थिति में अनुशासन एवं अनियमितता से समझौता नहीं किया जायेगा। एक सेमेस्टर में दो-तिहाई उपस्थिति से कम रहने वाले छात्र को परीक्षा में बैठने की अनुमति नहीं दी जा सकती है।
- 2. छेड़छाड़ से सीधे निष्कासन होगा। छात्रों को मर्यादा बनाए रखनी चाहिए और महाविद्यालय की छात्राओं और महिला स्टाफ के प्रति उचित सम्मान दिखाना चाहिए।
- 3. कॉलेज में धूम्रपान पर प्रतिबंध है। कॉलेज नो स्मोकिंग जोन है। उल्लंघन पर कड़ी सजा दी जाएगी।
- 4. प्रत्येक छात्र को अपना पहचान पत्र साथ रखना होगा और कॉलेज स्टाफ के किसी भी सदस्य द्वारा मांगे जाने पर उसे तुरंत प्रस्तुत करना होगा। पहचान पत्र खो जाने की स्थिति में कॉलेज को तुरंत सूचित किया जाना चाहिए और एफ.आई.आर. पुलिस में दर्ज कराया जाना चाहिए \mathbf{I} डुप्लीकेट कार्ड जारी करने के लिए $100/\mathbf{v}$ शुल्क लिया जाएगा।
- 5. विद्यार्थियों को सूचना पट्ट नियमित रूप से पढ़ना चाहिए। सभी जानकारी छात्रों को केवल छात्र नोटिस बोर्ड/कॉलेज की वेबसाइट पर नोटिस के माध्यम से सूचित की जाएगी।
- 6. कोई भी विद्यार्थी अपशब्दों का प्रयोग नहीं करेगा। यह ध्यान दिया जाना चाहिए कि कॉलेज क्षेत्र, धर्म, जाति, लिंग, सामाजिक स्थिति आदि के आधार पर किसी भी प्रकार के भेदभाव के प्रति शून्य सिहण्णुता की नीति का पालन करता है।
- 7. कॉलेज परिसर को साफ-सुथरा और अन्य कूड़े-कचरे से मुक्त रखा जाना चाहिए।
- 8. छात्रों से अपेक्षा की जाती है कि वे गलियारों में न घूमें या शोर न करें, खासकर जब कक्षाएं चल रही हों और प्रधानाचार्य कक्ष या कार्यालय के सामने समूहों में खड़े न हों।
- 9. कार्यालय से वांछित कोई भी जानकारी निर्धारित समय के दौरान काउंटर के माध्यम से मांगी जानी चाहिए।
- 10. छात्रों को कॉलेज के सभी समारोहों में भाग लेना आवश्यक है। सरकार प्रायोजित संगठनों को छोड़कर किसी भी सांस्कृतिक कार्यक्रम में किसी भी निजी ऑर्केस्ट्रा पार्टी या मंडली को अनुमित नहीं दी जाएगी, ऐसी स्थित में प्रिंसिपल से पूर्व अनुमित की आवश्यकता होगी।
- 11. कॉलेज की संपत्ति को नुकसान पहुंचाने या उसका दुरुपयोग करने पर सख्त अनुशासनात्मक कार्रवाई की जाएगी और न्यूनतम 500 रुपये का जुर्माना लगाया जाएगा।
- 12. जो भी छात्र प्राचार्य की अनुमति के बिना किसी बाहरी व्यक्ति को कॉलेज में बुलाएगा, उसे निलंबित कर दिया जाएगा और उसके खिलाफ कड़ी कार्रवाई की जाएगी।
- 13. जब तक छात्र फिट होने के बाद कॉलेज में शामिल होने पर तुरंत सरकारी अस्पताल/डिस्पेंसरी से मेडिकल प्रमाण पत्र प्रस्तुत नहीं करता, तब तक कोई चिकित्सा अवकाश नहीं दिया जाएगा। सत्र के अंत में किसी मेडिकल प्रमाणपत्र पर विचार नहीं किया जाएगा।
- 14. कक्षा/पुस्तकालय/गिलयारे/प्रयोगशालाओं में मोबाइल फोन का उपयोग सख्त वर्जित है। जो भी छात्र इस नियम का उल्लंघन करते हुए पाया जाएगा, उसके खिलाफ कड़ी कार्रवाई की जाएगी और जुर्माना लगाया जाएगा।
- 15. किसी भी नियम की अज्ञानता को बहाना नहीं माना जायेगा।

IMPORTANT RULES

- 1. Discipline and regularity shall not be compromised under any circumstance. A student falling short of two-third attendance in a semester may not be allowed to appear in the exams.
- 2. Eve-teasing would straight away lead to rustication. Boys must maintain decorum and show due respect towards girls and women staff of the college.
- 3. Smoking is banned in the College. The College is a *No Smoking Zone*. Violation shall attract strict punishment.
- 4. Every student must carry his identity card and present it immediately when asked for by any member of the college staff. In case of loss of Identity Card the college should be informed immediately and an **F.I.R.** should be lodged with the police. **Rs. 100/-** will be charged for issuing a duplicate card.
- 5. Students must read the Student Notice Board regularly. All information will be communicated to students only through notices on the Students' Notice Board/College website.
- 6. No student shall use abusive words. It may be noted that the college follows zero tolerance policy towards discrimination of any kind based on region, religion, caste, gender, social status, etc.
- 7. College premises must be kept clean and free of torn paper and other litter.
- 8. Students are expected not to loiter in the corridors or make a noise especially when classes are in progress and not to stand in groups in front of the Principal Room or the Office.
- 9. Any information desired form the office should be sought through the counter during the designated hours.
- 10. Students are required to attend all College functions. No private orchestra party or troupe would be allowed in any cultural programme except for Government sponsored organisations in which case prior permission from the Principal will be required.
- 11. Damaging or mishandling of College property shall be dealt with strict disciplinary action and invite a minimum fine of Rs. 500/-
- 12. Any student who invites an outsider in the college without the permission of the Principal will be suspended and strong action will be taken against him.
- 13. No medical leave will be granted unless the student produces a medical certificate from a Government Hospital / Dispensary immediately upon joining the college after becoming fit. No Medical Certificate will be entertained at the end of the session.
- 14. The use of Mobile phones is strictly prohibited in the classroom /Library/Corridors/Laboratories. Any student found violating this rule shall face stringent action and imposition of fines.
- 15. Ignorance of any rule shall not be accepted as an excuse.


- 1. अनुशासन एवं अनुशासनात्मक कार्रवाई से संबंधित सभी शक्तियां कुलपति में निहित हैं।
- 2. कुलपित सभी या ऐसी शक्तियां, जो वह उचित समझे, प्रॉक्टर और ऐसे अन्य व्यक्तियों को सौंप सकता है, जिन्हें वह इस संबंध में निर्दिष्ट कर सकता है।
- 3. अध्यादेश के तहत अनुशासन लागू करने की शक्ति की व्यापकता पर प्रतिकूल प्रभाव डाले बिना निम्नलिखित को घोर अनुशासनहीनता के कार्य माना जाएगा:
- किसी भी संस्थान/विभाग के शिक्षण और गैर-शिक्षण स्टाफ के किसी भी सदस्य के खिलाफ और दिल्ली विश्वविद्यालय के भीतर किसी भी छात्र के खिलाफ शारीरिक हमला, या शारीरिक बल का उपयोग करने की धमकी
- किसी भी हथियार को ले जाना, उपयोग करना या उपयोग करने की धमकी देना
- नागरिक अधिकार संरक्षण अधिनियम, 1976 के प्रावधानों का कोई भी उल्लंघन
- अनुसूचित जाति और जनजाति के छात्रों की स्थिति, गरिमा और सम्मान का उल्लंघन
- कोई भी प्रथा-चाहे मौखिक हो या अन्यथा-महिलाओं का अपमान करने वाली हो
- किसी भी तरह से रिश्वत देने या भ्रष्टाचार करने का कोई भी प्रयास
- संस्थागत संपत्ति का जानबूझकर नष्ट करने पर कड़ी कार्रवाई।
- धार्मिक या सांप्रदायिक आधार पर द्वेष या असहिष्णुता पैदा करना
- विश्वविद्यालय प्रणाली के शैक्षणिक कामकाज में किसी भी तरह से व्यवधान उत्पन्न करना;
- अध्यादेश XV-सी के अनुसार रैगिंग पर पूर्णतः प्रतिबंध।
- 4. अनुशासन बनाए रखने से संबंधित अपनी शक्तियों की व्यापकता पर प्रतिकूल प्रभाव डाले बिना और अनुशासन बनाए रखने के हित में ऐसी कार्रवाई करना जो उसे उचित लगे, कुलपित अपने प्रयोग में ऐसा कर सकता है। उपरोक्त शक्तियां आदेश या निर्देश देती हैं कि कोई भी छात्र या छात्राएँ -
- एक निश्चित अवधि के लिए निष्काषित किया जाए; या
- किसी निर्दिष्ट अवधि के लिए विश्वविद्यालय के किसी कॉलेज, विभाग या संस्थान में किसी कार्यक्रम या अध्ययन कार्यक्रमों में प्रवेश नहीं दिया जाना चाहिए; या
- निर्दिष्ट रुपये की राशि का जुर्माना लगाया जाएगा; या

• एक या अधिक वर्षों के लिए विश्वविद्यालय या कॉलेज या विभागीय परीक्षा या परीक्षाओं में भाग लेने से वंचित किया जाएगा; या संबंधित छात्र या छात्रा जिस परीक्षा या परीक्षा में शामिल हुए हैं उसका परिणाम रद्द कर दिया जाए।

संबंधित विभागों में संस्थान, हॉल और शिक्षण। वे अपना व्यायाम कर सकते हैं

अपने कॉलेजों, संस्थानों या विभागों में ऐसे शिक्षकों के माध्यम से प्राधिकरण, या उन्हें अधिकार सौंपना, जैसा कि वे इन उद्देश्यों के लिए निर्दिष्ट कर सकते हैं।

5. जैसा कि ऊपर कहा गया है, कुलपित और प्रॉक्टर की शक्तियों पर प्रितकूल प्रभाव डाले बिना, अनुशासन और उचित आचरण के विस्तृत नियम बनाए जाएंगे। इन नियमों को, जहां आवश्यक हो, इस विश्वविद्यालय में कॉलेजों के प्राचार्यों, हॉलों के प्रमुखों, संकायों के डीन और शिक्षण विभागों के प्रमुखों द्वारा पूरक किया जा सकता है। प्रत्येक छात्र से अपेक्षा की जाएगी कि वह स्वयं इन नियमों की एक प्रित उपलब्ध कराए। प्रवेश के समय, प्रत्येक छात्र को एक घोषणा पत्र पर हस्ताक्षर करना होगा कि प्रवेश पर वह स्वयं को अनुशासनात्मक क्षेत्राधिकार के अधीन प्रस्तुत करता है। कुलपित और विश्वविद्यालय के कई प्राधिकारी जिन्हें विश्वविद्यालय द्वारा बनाए गए अधिनियमों, क़ानूनों, अध्यादेशों और नियमों के तहत अनुशासन का अभ्यास करने का अधिकार दिया जा सकता है।





DISCIPLINE POLICY

Successful applicants will be required to abide by the Ordinances of the University and willbe required to provide a written undertaking to this effect at the time of admission. A few extracts of important ordinances are reproduced here.

ORDINANCE XV-B: Maintenance of discipline among Students of the University

- 1. All powers relating to discipline and disciplinary action are vested in the Vice-Chancellor.
- 2. The Vice-Chancellor may delegate all or such powers as he / she deems proper to the Proctor and to such other persons as he/she may specify in this behalf.
- 3. Without prejudice to the generality of power to enforce discipline under the Ordinance the following shall amount to acts of gross indiscipline:
 - Physical assault, or threat to use physical force, against any member of the teaching and nonteaching staff of any Institution / Department and against any student within the University of Delhi
 - Carrying of, use of or threat to use of any weapons
 - Any violation of the provisions of the Civil Rights Protection Act, 1976
 - Violation of the status, dignity and honour of students belonging to the scheduled castes and tribes
 - Any practice-whether verbal or otherwise-derogatory of women
 - Any attempt at bribing or corruption in any manner
 - Willful destruction of institutional property
 - Creating ill-will or intolerance on religious or communal grounds
 - Causing disruption in any manner of the academic functioning of the University system;
 - Prohibition of Ragging as per Ordinance XV-C.
- 4. Without prejudice to the generality of his / her powers relating to the maintenance of discipline and taking such action in the interest of maintaining discipline as may seem to him/her appropriate, the Vice-Chancellor, may in the exercise of his / her powers aforesaid order or direct that any student or students -
 - be expelled; or
 - be, for a stated period rusticated; or
 - be not for a stated period, admitted to a programme or programmes of study in a College, Department or Institution of the University; or
 - be fined with a sum of rupees that may be specified; or
 - be debarred from taking a University or College or Departmental Examination or Examinations for one or more years; or that the result of the student or students concerned in the Examination or Examinations in which he /she or they have appeared be cancelled.

Institutions, Halls and teaching in the concerned Departments. They may exercise their

authority through, or delegate authority to such of the teachers in their Colleges, Institutions or Departments as they may specify for these purposes.

5. Without prejudice to the powers of the Vice-Chancellor and the Proctor as aforesaid, detailed rules of discipline and proper conduct shall be framed. These rules may be supplemented, where necessary, by the Principals of Colleges, Heads of Halls, Deans of Faculties and Heads of Teaching Departments in this University. Each student shall be expected to provide himself / herself with a copy of these rules. At the time of admission, every student shall be required to sign a declaration that on admission he /she submits himself / herself to the disciplinary jurisdiction of the

Vice-Chancellor and several authorities of the University who may be vested with the authority to exercise discipline under the Acts, the Statutes, the Ordinances and the rulesthat have been framed there in by the University.



नियम और अध्यादेश

उपस्थिति

छात्र/छात्रा जिनकी उपस्थिति व्याख्यान स्यूटोरियल प्रे सप्टोरियल प्रायो गक कक्षाओं में न्यूनतम 66% नहीं होगी, उन्हें वश्व वद्यालय की परीक्षा में बैठने की अनुमति नहीं दी जाएगी।

कक्षा में उपस्थिति: आदर्श रूप से, छात्रों को वर्षभर में सभी वषयों (या पेपरों) में आयोजित सभी व्याख्यान, प्रे सप्टोरियल, ट्यूटोरियल और प्रायो गक कक्षाओं में भाग लेना होगा। यदि छात्र/छात्रा ऐसा करने में असमर्थ है, तो उसे निम्न ल खत होना चाहिए:

- (a) सभी तीन वर्षों के पाठ्यक्रम में सभी पेपरों में सद्धांत (व्याख्यान, प्रे सप्टोरियल, ट्यूटोरियल) और प्रायो गक कक्षाओं में न्यूनतम 66% उपस्थिति होनी चाहिए। अन्यथा, उसे वार्षक परीक्षा देने की अन्मति नहीं दी जाएगी।
- (b) कृपया ध्यान दें क पहले वर्ष में गैर-क्रे डट पेपर में भी 66% उपस्थिति आवश्यक है, अन्यथा छात्र / छात्रा को वशेष पेपर की वार्षक परीक्षा में बैठने की अन्मति नहीं दी जाएगी।
- (c) वश्व वद्यालय के नियम के अनुसार, यदि छात्र / छात्रा के पास पहले वर्ष में 40% उपस्थिति है और पहले और दूसरे वर्षों में मलाकर 55% से कम नहीं है, तो उसे वश्व वद्यालय परीक्षा में बैठने की अनुमित दी जाएगी ले कन संबं धत छात्र को एक अंडरटे कंग पर हस्ताक्षर करना होगा क उपस्थिति की कमी अगले वर्ष पूरा करेगा । कृपया ध्यान दें क व्याख्यान और प्रायो गक कक्षाओं में उपस्थिति को अलग-अलग जोड़ा जाएगा।

सभी तीन वर्षों में मलाकर, सद्धांत (व्याख्यान, प्रे सप्टोरियल, ट्यूटोरियल) और प्रायो गक कक्षाओं में 66% उपस्थिति न प्राप्त करने पर छात्र / छात्रा को वार्षक परीक्षा में बैठने के लए अनुमित नहीं दी जाएगी । इसके अतिरिक्त, प्रत्येक वर्ष में न्यूनतम 40% उपस्थिति अनिवार्य है।

यदि छात्र / छात्रा की उपस्थिति कम है, तो उसे वश्व वद्यालय के नियम के अनुसार परीक्षा देने से वं चत कर दिया जाएगा। छात्र / छात्रा जिसे रोका गया है, उसे अगले वर्ष कॉलेज में पुनः प्रवेश लेना होगा और जिस वर्ष में उपस्थिति कम थी। उसकी उपस्थिति की नई गणना की जाएगी और पछले वर्ष की उपस्थिति रद्द कर दी जाएगी। हालां क, उसने जिन वर्षों को पूरा कया है (क्लियर कया है) उनकी उपस्थिति अपरिवर्तित रहेगी।



RULES AND ORDINANCES

ATTENDANCE

Students who fail to attend a minimum of 66% of the lecture/tutorial/preceptorial/practical classes will be detained and not permitted to appear in the University Examination.

Attendance in classes: Ideally, students should attend all lectures, preceptorials, tutorials and practicals held during the year in all subjects (or papers). In case the student is unable to do so, then she must have:

- (a) A minimum of 66% in theory (lectures, preceptorials, tutorials) and practicals separately in all the papers, for all three years of the course. Failing this, she will not be permitted to take the annual examination.
- (b) Please note that 66% attendance is also required in the non-credit paper in the first year, failing which the student will not be allowed to appear in the annual examination of the particular paper.
- (c) University rules permit a student to appear for the University examination if she has 40% attendance in the I year, and not less than 55% in the I and II years (combined). However, the concerned student will be required to sign an undertaking that the shortage in attendance will be made up in the following year. Please note that attendance in lectures and practical will be calculated separately.

A failure to secure 66% attendance in all three years combined, in theory (lectures, preceptorials, tutorials) and practicals, calculated separately, will render the student ineligible to sit for the annual examination. Moreover, it is mandatory to have a minimum attendance of 40% in each year.

If a student is short of attendance, she will be detained, as per university rules. A student who has been detained will have to rejoin the college the following year and repeat the year in which she was short of attendance. Her attendance will be calculated afresh, and the attendance that had accrued for the previous year will stand cancelled. However, attendance for the years she has completed (cleared) will remain unchanged.



रैगिंग - निषेध और सजा

- 1. कॉलेज/वभाग या संस्थान के परिसर और दिल्ली वश्व वद्यालय प्रणाली के कसी भी हिस्से के साथ-साथ सार्वजनिक परिवहन पर कसी भी रूप में रै गंग सख्ती से प्रतिबंधत है।
- 2. रै गंग का कोई भी व्यक्तिगत या सामूहिक कार्य या अभ्यास घोर अनुशासनहीनता है और इससे इस अध्यादेश के तहत निपटा जाएगा।
- 3. इस अध्यादेश के प्रयोजनों के लए रै गंग का मतलब सामान्यतः ऐसा कोई कार्य, आचरण या अभ्यास है जिसके द्वारा विरष्ठ छात्रों की प्रमुख शक्ति या स्थिति को नए नामां कत छात्रों या उन छात्रों पर लागू कया जाता है जिन्हें कसी भी तरह से अन्य छात्रों द्वारा जूनियर या हीन माना जाता है; और इसमें व्यक्तिगत या सामूहिक कार्य या प्रथाएँ शा मल हैं जो:

इसमें शारीरिक हमला या शारीरिक बल प्रयोग की धमकी शा मल है।

महिला छात्रों की स्थिति, गरिमा और सम्मान का उल्लंघन करना।

अन्सू चत जाति और जनजाति के छात्रों की स्थिति, गरिमा और सम्मान का उल्लंघन करना।

वद्या थेयों को उपहास और अवमानना के लए उकसाना और उनके आत्मसम्मान को प्रभा वत करना।

इसमें मौ खक दुर्व्यवहार और आक्रामकता, अभद्र इशारे और अश्लील व्यवहार शा मल हैं

- 4. कसी कॉलेज के प्राचार्य, वभाग या संस्थान के प्रमुख, कॉलेज या वश्व वद्यालय छात्रावास या निवास हॉल के अधकारी रैगंग की घटना की कसी भी सूचना पर तत्काल कार्रवाई करेंगे।
- 5. उपरोक्त खंड में कसी भी बात के बावजूद, प्रॉक्टर रै गंग की कसी भी घटना की स्वतः जांच कर सकता है और रै गंग में शा मल लोगों की पहचान और घटना की प्रकृति के बारे में कुलपति को रिपोर्ट कर सकता है।
- 6. प्रॉक्टर रै गंग के अपरा धर्यों की पहचान और रै गंग घटना की प्रकृति स्था पत करने वाली एक प्रारं भक रिपोर्ट भी प्रस्तुत कर सकता है।
- 7. यदि कसी कॉलेज के प्राचार्य या वभाग या संस्थान के प्रमुख या प्रॉक्टर इस बात से संतुष्ट हैं क कसी कारण से, लखत रूप में दर्ज कए जाने पर, ऐसी जांच करना उ चत रूप से व्यावहारिक नहीं है, तो वह वाइस को सलाह दे सकते हैं -कुला धपित तदनुसार.
- 8. जब कुलपति संतुष्ट हो जाए क ऐसी जांच कराना समीचीन नहीं है, तो उसका निर्णय अंतिम होगा।
- 9. खंड (5) या (6) के तहत एक रिपोर्ट की प्राप्ति पर या खंड (7) के तहत संबंधत प्राधकारी द्वारा खंड 3 (ए), (बी) और (सी) में वर्णत रैगंग की घटनाओं का खुलासा करने वाले निर्धारण पर। कुलपति कसी छात्र या छात्राओं को वशष्ट वर्षों के लए निष्का सत करने का निर्देश या आदेश देगा।
- 10. कुलपित रै गंग के अन्य मामलों में आदेश या निर्देश दे सकते हैं क कसी भी छात्र या छात्रा को निष्का सत कर दिया जाए या एक निश्चित अव ध के लए कॉलेज में अध्ययन के कार्यक्रम में प्रवेश न दिया जाए, एक या अ धक वर्षों के लए वभागीय परीक्षा दी जाए या संबंधत छात्र या छात्राएं जिस परीक्षा या परीक्षा में शा मल हुए थे, उसका परिणाम रद्द कर दिया जाए।

- 11. यदि दिल्ली वश्व वद्यालय से डग्री या डप्लोमा प्राप्त करने वाला कोई भी छात्र दोषी पाया जाता है; इस अध्यादेश के तहत वश्व वद्यालय द्वारा प्रदान की गई डग्री या डप्लोमा को वापस लेने पर परिनियम 15 के तहत उ चत कार्रवाई की जाएगी।
- 12. इस अध्यादेश के प्रयोजन के लए, रै गंग के लए उकसाना, चाहे वह कसी कार्य, अभ्यास या रै गंग के लए उकसाना हो, भी रै गंग की श्रेणी में आएगा।
- 13. दिल्ली वश्व वद्यालय प्रणाली के अंतर्गत सभी संस्थान निर्देशों का पालन करने के लए बाध्य होंगे

/इस अध्यादेश के तहत जारी निर्देश, और अध्यादेश के प्रभावी कार्यान्वयन को प्राप्त करने के लए क्लपति को सहायता प्रदान करना।

अध्यादेश XV-सी के अनुसरण में कुलपति का आदेश:

जहां इस अध्यादेश के तहत कसी प्राधकारी द्वारा रै गंग की घटनाओं की सूचना कुलपित को दी जाती है, वहां रै गंग में शा मल छात्रों को आदेश में निर्दिष्ट एक निर्दिष्ट अवध के लए निष्का सत कर दिया जाएगा। रै गंग की रिपोर्ट में शा मल गैर-छात्रों के खलाफ कार्रवाई की जाएगी।

भारत का आपरा धक कानून; उन्हें दिल्ली वश्व वद्यालय के कसी भी संस्थान में नामांकन लेने से पांच साल की अवध के लए अयोग्य घो षत कर दिया जाएगा। जिन छात्रों के खलाफ इस नोट के तहत आवश्यक कार्रवाई की गई है, उन्हें प्राकृतिक न्याय के नियमों का सख्ती से पालन करते हुए निर्णय के बाद स्नवाई का मौका दिया जाएगा।

RAGGING - PROHIBITION AND PUNISHMENT

- 1. Ragging in any form is strictly prohibited, within the premises of College / Department or Institution and any part of Delhi University system as well as on public transport.
- 2. Any individual or collective act or practice of ragging constitutes gross indiscipline and shall be dealt with under this Ordinance.
- 3. Ragging for the purposes of this Ordinance, ordinarily means any act, conduct or practice by which dominant power or status of senior students is brought to bear on students freshly enrolled or students who are in any way considered junior or inferior by other students; and includes individual or collective acts or practices which:
 - Involve physical assault or threat to use of physical force.
 - Violate the status, dignity and honour of women students.
 - Violate the status, dignity and honour of students belonging to the scheduled caste and tribe.
 - Expose students to ridicule and contempt and affect their self-esteem.
 - Entail verbal abuse and aggression, indecent gestures and obscene behavior
- 4. The Principal of a College, the Head of the Department or an Institution, the authorities of College, or University Hostel or Halls of Residence shall take immediate action on any information of the occurrence of ragging.
- 5. Notwithstanding anything in Clause above, the Proctor may also suomoto enquire into any incident of ragging and make a report to the Vice-Chancellor of the identity of those who have engaged in ragging and the nature of the incident.
- 6. The Proctor may also submit an initial report establishing the identity of the perpetrators of ragging and the nature of the ragging incident.
- 7. If the Principal of a College or Head of the Department or Institution or the Proctor is satisfied that for some reason, to be recorded in writing, it is not reasonably practical to hold such an enquiry, he/ she may so advise the Vice-Chancellor accordingly.
- 8. When the Vice-Chancellor is satisfied that it is not expedient to hold such an enquiry, his/her decision shall be final.
- 9. On the receipt of a report under Clause (5) or (6) or a determination by the relevant authority under clause (7) disclosing the occurrence of ragging incidents described in Clause 3(a), (b) and (c) the Vice-Chancellor shall direct or order rustication of a student or students for a specific number of years.
- 10. The Vice-chancellor may in other cases of ragging order or direct that any student or students be expelled or be not for a stated period, admitted to a programme of study in a college, departmental examination for one or more years or that the results of the student or students concerned in the examination or examinations in which they appeared be cancelled.
- 11. In case any students who have obtained degrees or diplomas of the University of Delhi are found guilty; under this Ordinance, appropriate action will be taken under Statute 15 for withdrawal of degrees or diploma conferred by the University.

- 12. For the purpose of this Ordinance, abetment to ragging whether by way of any act, practice or incitement of ragging will also amount to ragging.
- 13. All Institutions within the Delhi University system shall be obligated to carry out instructions / directions issued under this Ordinance, and to give aid assistance to the Vice-Chancellor to achieve the effective implementation of the Ordinance.

ORDER OF THE VICE-CHANCELLOR IN PURSUANCE OF ORDINANCE XV-C:

Where incident(s) of ragging are reported to the Vice-Chancellor by any authority under this Ordinance, the students(s) involved in ragging, shall be expelled for a specified term, designated in the order. Non-students involved in reports of ragging will be proceeded with under the criminal law of India; they will also be rendered ineligible for a period of five years from seeking enrolment in any of the institutions of the University of Delhi. Students against whom necessary action is taken under this note, will be given post decisional hearing, with strict adherence to the rules of natural justice.






